
CONSENT FORM FOR TRAINING ATTENDANCE AND PERSONAL DATA MANAGEMENT

1. Training Attendance

I acknowledge that the training includes the activities listed below and agree to assume responsibility for any incidents that may occur during training, except in cases of gross and obvious negligence by the training provider. This consent form must be completed and submitted prior to the start of training:

a) Basic Safety Training (BST):

1. First aid, including CPR using dummy dolls and Automated External Defibrillators (AED).
2. Manual handling involving carrying dummy dolls and heavy objects (30 kg to 50 kg).
3. Ladder skills including ascending and descending (max. 6 meters).
4. High-access evacuation and descent drills (max. 10 meters).
5. Rescue operations for individuals suspended from structures (max. 6 meters).
6. Transfers from crew transfer vessels to structures.
7. Water-based evacuation and descent drills from heights (up to 7 meters).
8. Sea survival techniques in a 3.5-meter-deep pool using life rafts and life jackets.
9. Emergency lifting and rescue operations using lifesaving equipment.
10. Basic firefighting using fire extinguishers and fire blankets.
11. Evacuation exercises in low visibility and smoke-filled environments.

b) Basic Technical Training (BTT):

1. Bolt-tightening techniques using simulators and tools.
2. Electrical safety and high-voltage handling using simulators.
3. Hydraulic systems operation using hydraulic simulators.
4. Assembly and connection of various mechanical components.

c) Advanced Rescue Training (ART):

1. Advanced rescue techniques using specialized equipment.
2. High-altitude rescue operations (max. 10 meters).
3. Rescue operations in confined spaces.

Participants are expected to engage in training responsibly and safely. I agree to adhere to all instructions provided by my instructor and understand that failure to participate in any practical part of the training without an instructor's approval may result in not receiving a training certificate. I consent to receiving first aid from the instructor and will comply with evacuation procedures if necessary.

2. Personal Data

I consent to the handling of my personal data as follows:

A) Use of Personal Information:

1. Personal data collected during the training will be used solely for conducting and enhancing the training.
2. Information may be used for billing purposes and for sending course invitations.
3. Photographs and videos taken during training will be used only in ways that do not identify individuals.
4. All other uses of personal data will support the training objectives.

B) Disclosure of Personal Data to Third Parties:

Personal data may be disclosed to third parties under the following conditions:

1. With explicit consent from the individual concerned.
2. When legally required.
3. Upon request from GWO Headquarters.
4. If necessary to protect the life, health, or safety of any individual.
